

# Basic rights for private rental sector tenants

This fact sheet gives you some information about your rights as a tenant of a private landlord. This factsheet is created by TPAS Cymru in partnership with 6 Local Authorities. (Conwy, Denbighshire, Flintshire, Ynys Mon, Wrexham and Gwynedd).

We have created this factsheet after tenant requests for a factsheet covering basic rights for PRS tenant.

# Here are some basic rights all private rental tenants have:

- All private tenants should be given a written Occupation Contract from their landlord by June 2023. This Contract can be a printout or sent online. This written Contract will tell you about your rights and responsibilities, and what the landlord can and can't do. You should sign the contract if you're happy with everything in it.
- If you haven't had an Occupation Contract from your landlord you should contact your Local Council for further information.
- Landlords must make sure your home is fit to live in e.g. have a smoke alarm fitted; that the electricity is safe.
- If your landlord wants you to leave their property they must give you a written notice to do so.
- Your Landlord cannot ask you leave just because you have complained that your home is in a poor state of repair. You must report repairs to your landlord.
